The scope of the Compliance management system includes all direct and indirect departments that are involved in the realisation and support of our finished products.

During the planning, design and procurement stage, consideration shall be given to the suitability, energy efficiency and sustainability of products and services used. Kingspan will strive to exert influence on all suppliers of raw materials, goods and services to improve their own management systems. Top management will ensure all business units demonstrate transparency in MS performance and compliance governance to regulators, stakeholders and other interested parties.

The IMS provides a framework for establishing performance indicators in support of improvement objectives and policy. Top management shall review the overall effectiveness of the IMS by evaluating performance against targets and intended outcomes, propose and implement new improvement plans in line with business needs and strategy.

Adequate provision of resources will be available in support of IMS improvement plans, Op Ex initiatives and the effective operation of our compliance functions. Kingspan will appoint persons to provide information, instruction, training and supervision, including competent advice and assistance for management and staff, to help understand the benefits of improved performance, their legal & compliance obligations, responsibilities, and the consequences of non-conformance.

Overall responsibility for declared policy rests at top management level. Board members shall demonstrate leadership, commitment and promote consultation with employees, which encourages a culture of compliance and active participation in reporting; opportunities, risks, incidents and concerns, without concern of reprisal.

Kingspan policy is made available through corporate media and upon request to interested parties. Policy and supporting procedures are communicated at all levels in the organisation.
